O R D E R

Now, on this the 31st. day of May, 1927, the matter of the petition of C C DEAN, an individual, for permission to lay a two (2") inch water pipe line along, under and across certain highways in County and State, came up before the Board of County Commissioners of said County for hearing, and it appearing to the Board, and each of the Commissioners thereof, that it was just that the said C C DEAN be permitted to use as much of the highways as designated by the hereinafter description, which is as follows, to-wit:

Beginning at the Northwest corner of the Northeast
Quarter of the North West Quarter of Section Thirty
(30) Township Twenty One (21), North, Range Fourteen
(14) East; thence along the South side of the
Right of Way to the present paved highway.

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the right of the general public in the use of said highways; and will be constructed in accordance with all rules of the County Commissioners and the laws of the State of Oklahoma governing same.

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted C C DEAN, his successors and assigns, to use as much of the highways as above designated.
