R E S O L U T I O N

WHEREAS, under the provisions of Senate Bill 365, Laws of Oklahoma, 1925, an Act relating to depositories of County Funds, it is hereby resolved by the Board of County Commissioners of Tulsa County, in regular monthly session assembled, that all Banks, be the same State or National, operating and conducting business in Tulsa County be, and the same are hereby designated subject to the provisions of said Senate Bill Number 365 aforesaid,
