CORRECTION ORDER OF THE BOARD OF COUNTY COMMISSIONERS
OF TULSA COUNTY, OKLAHOMA, RELATING TO THE SALE OF
COUNTY PROPERTY ACQUIRED AT RESALE

WHEREAS, the County Treasurer has presented to this Board a transcript of an order of his proceedings, with all papers and proofs relating to the sale of the following described property, to-wit:

Northeast Quarter of the Northwest Quarter of Section 32,
Township 20 North, Range 13 East of the Indian Base and
Meridian in Tulsa County, State of Oklahoma, according to
the government survey thereof;

AND, WHEREAS, the said sale was conducted on April 1, 1940, and S. G. Freeman ordered the highest competitive bid, all in accordance with the County Treasurer's transcript of proceedings on sale of county property acquired at resale;

AND, WHEREAS, the County Treasurer has presented said proceedings to this Board for approval of the Board of County Commissioners;

This Board of County Commissioners, being duly convened in the office of the County Clerk of Tulsa County, State of Oklahoma, on the date hereinafter set forth:

We have carefully examined said transcript and proceedings and find that the above described property was sold to S. G. Freeman for the sum of \$2,850.00 and the sum of \$6.00 as an additional and separate charge, and that said sale was properly advertised and fairly conducted and the amount of the sale is deemed a fair price.

WHEREAS, the Board of County Commissioners of Tulsa County, Oklahoma, on the 20th day of April, 1940, approved and confirmed said sale in accordance with the order entered, but that said order was in error in that it stated that the property was sold to Cecil L. Henry and that a deed should be issued to Cecil L. Henry conveying said property, but in truth and fact, the sale was made to S. G. Freeman and that the inclusion of the name of Cecil L. Henry in said order of April 20, 1940, was a clerical error and should have been S. G. Freeman, and this order is made to correct the said clerical error.

Therefore, so finding, the Board of County Commissioners of Tulsa County, State of Oklahoma, does hereby order and direct that the foregoing sale be approved, and the Chairman of the Board of County Commissioners of Tulsa County, Oklahoma, is hereby ordered and directed to execute a deed conveying the foregoing described property to S. G. Freeman in as full and complete a manner as the County is authorized to convey it, and the County Treasurer is ordered and directed upon the execution of said deed to pay into the proper funds and accounts the moneys heretofore received by him in consideration thereof.

IT IS ORDERED that the County Deed executed by the Chairman of the Board of County Commissioners of Tulsa County, State of Oklahoma, to S. G. Freeman covering the above described property, dated April 20, 1940, filed May 10, 1940, and recorded in Book 1376, Page 265, for a consideration of \$2,850.00 be, and the same is hereby ratified and confirmed, and this correction order approving the said sale to S. G. Freeman is hereby entered nunc pro tunc as of April 20, 1940.
