RESOLUTION

WHEREAS, the County of Tulsa in conjunction with the department of highways of the State of Oklahoma and the Bureau of Public Roads, is preparing to construct, grade and drain and otherwise improve for road and highway purposes, a Limited Access Boulevard Connection beginning approximately $\frac{1}{4}$ mile south of 51st Street on US Highway 66 and extending North and East to the West approach to the 51st Street bridge as a limited access Boulevard and Parkway on the State Highway System with the aid of State and Federal Funds in accordance with plans and specifications designated as Federal Aid Project No. U-U1-591(4), in Tulsa County, Oklahoma.

WHEREAS, for the proper construction of said road and roadway and its intersections and access facilities, it is necessary that the County acquire for right-of-way purposes, the following lot or parcel of land situated in Tulsa County, Oklahoma, described as follows, to-wit:

A portion of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 35, Twp. 19N, Range 12E, of the Indian Base and Meridian, Tulsa County, Oklahoma, more particularly described as follows, to-wit:

Commencing at a point 440 feet east and 193.27 feet South of the NW corner of the NE $\frac{1}{4}$ of said Section 35-19-12; thence in an Easterly direction to a point, said point being 488.99 feet East and 177.54 feet South of the said NW corner of said NE $\frac{1}{4}$ of said Section 35-19-12; thence continuing in an Easterly direction to a point, said point being 360.47 feet West and 61.89 feet South of the Northeast corner of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Section 35-19-12; thence in a Northerly direction, a distance of 27.71 feet to a point, said point being 367.17 feet West and 35 feet South of the said Northeast corner of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Sec. 35-19-12; thence N a distance of 35 feet to a point on the North Line of said Sec. 367.17 feet West of the said NE corner of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Sec. 35-19-12; thence East along the North Line of said Sec. 35-19-12; a distance of 367.17 feet to the said NE corner of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Sec. 35-19-12; thence South along the East line of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Sec. 35-19-12, a distance of 188.44 feet to a point; thence in a Southwesterly direction, a distance of 736.2 feet to a point, said point being 714.33 feet West and 366.54 feet South of the said NE corner of said NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of said Sec. 35-19-12; thence in a Northerly direction, a distance of 13 feet to a point, said point being 602.67 feet East and 353.82 feet South of the NW corner of the said NE $\frac{1}{4}$ of said Sec. 35-19-12; thence continuing in a Westerly direction to a point of curve, said point being 542.97 feet East and 368.82 feet South of the said NW corner of said NE $\frac{1}{4}$ of said Sec. 35-19-12; thence continuing in a Westerly direction around a curve to the right having a radius of 2,971.93 feet to a point, said point being 440 feet East and 392.52 feet South of the said Northwest corner of said NE $\frac{1}{4}$ of said Sec. 35-19-12; thence North along a line parallel to the said North and South center line of Sec. 35-19-12, a distance of 199.25 feet to the place of beginning.
