Motion was made by Mr. Bohnefeld, that an allowance by and the same is hereby granted to LAURA MAY JONES, Jenks, Oklahoma, in the amount of \$10.00, effective February 1st. 1932, until furthernotice. Motion seconded by Mr. North and declared carried.
