NOTICE OF HEARING.

NOTICE IS HEREBY GIVEN, That upon the 21st. day of October, 1929, W P Phillips, et al, consisting of five or more residents of Tulsa County, Oklahoma, claiming to be affected by the proposed Drainage District and improvements, filed their petition for the establishment of a Drainage District and the construction of drainage improvements beginning at a point at or near the Northwest corner of said Tulsa County, and running in a southerly and slightly southeastern direction, following the line of BIRD CREEK, and on both sides thereof, to a point or points on the North line of Mohawk Park, accompanied by a Bond to cover costs and expenses in case said petition was denied or dismissed; and that thereafter and upon said day, the said board of County Commissioners for Tulsa County Oklahoma, having ordered said petition filed, and having approved said bond, appointed Frank F Cochran, W J Ruyle and Claude Sample, three resident freeholders of said County having no interest
