And to accept the petition to cross the St. Louis and San Francisco Railroad.

RESOLUTION

WHEREAS, W. R. Kelly and G. W. Ramsey have petitioned the Board of County Commissioners of Tulsa County and the Corporation Commission of the State of Oklahoma to create and open a grade crossing across the railroad right-of-way of the St. Louis and San Francisco Railroad (Howard Branch) at the intersection of said right-of-way with a westerly extension of Independence Street in Tulsa County, Oklahoma, which Independence Street is shown on the recorded plat of Mary Ellen Second Addition, an addition to the city of Tulsa, Oklahoma, and

WHEREAS, it is to the best interest of the petitioners, the county, and all other parties which will be affected by the creation of said grade crossing that same should be opened and that the opening thereof is necessary in order to make the land lying west of said railroad right-of-way available for development for industrial purposes;

NOW, THEREFORE, BE IT RESOLVED that the Corporation Commission of the State of Oklahoma be, and it is hereby requested to require the St. Louis and San-Francisco Railroad Company to promptly open a grade crossing at the intersection of its right-of-way above described, with the westerly extension of Independence Street above referred to, and that the County Attorney of Tulsa County is hereby authorized and directed to file a copy of this resolution, together with a copy of the aforesaid petition as the petition of the said County Commissioners for the opening of said grade crossing above referred to.
