in said improvement, viewers for said proposed District; and that upon the 4th. day of Nov. 1929, the said viewers filed with said Board of County Commissioners their report which was signed by them upon the 29th. day of October, 1929, and is as follows:

"We, the Viewers, appointed by the Board of County Commissioners of Tulsa County, Oklahoma, to view the lands lying in and adjacent to the proposed ditch and drainage improvements and said Drainage District sought to be established as petitioned for by W P. Phillips, et al, do hereby report as follows:

That we first took and subscribed the cath of :ffice to faithfully and impartially discharge our duties as such Viewers and to truly and correctly make and return the report required by Chapter 35, Compiled Oxlahoma Statutes of 1921; that we then proceeded to view the proposed line of the proposed drain and drainage improvements, and the lands along and adjacent thereto, and the whole of said Drainage District, accompanied by John C. Milliken, one of the Engineers appointed by said Board of County Commissioners, and after so viewing said lands and said proposed Drainage District we do hereby report that the proposed improvements are practicable and necessary and of both private and public utility and benefit and we do hereby recommend the following route for said Drainage District, to-wit: Commencing at the North Line of Tulsa County Oklahoma, in the Northwest corner thereof, with all that part of Section Two, in Town 22, North Range 12 East lying in said Tulsa County, and continuing in a southernly and slightly southeastern direction from said place of beginning, following the general direction of BIRD CREEK, and extending on both sides of it, to and including the S2 of the NE, the N2 of the SE, the SE of the NW and NE of SW of Sec. 8, and the N2 of the NE, and the parts of the NW, and the NW of the SW, lying North of Mohawk Park, in Section 9, all in Town 20 North, Range 13, East, Tulsa County, Oklahoma, together with all intervening and other lands as shown by the map attached to the petition filled by W P. Phillips, et all, all in Tulsa County, Oklahoma, and we do further recommend that all of the work be let by contract without allotment\*.

FURTHER NOTICE IS HIREBY GIVEN, that pursuant to an order duly made by said Board of County Commissioners for Tulsa County, Oklahoma, on the 4th day of November, 1929, a hearing will be had upon said petition for said Drainage District and said Drainage Improve ments, and upon said report of said Viewers, on the 2nd. day of December, 1929, at the hour of 1:30 P M at the office of the Board of County Commissioners of Tulsa County Oklahoma, in the Court House at Tulsa, Oklahoma, and that any person interested in land which will be affected by said proposed drain and drainage improvement may file in the office of the County Clerk, on or before the day wet for a hearing, a written objection against the same, and that said objections, if any, will be heard and determined with said petition and report and that all persons interested may appear and show cause, if any, why said drainage district should not be established as located by said petition and the report of said Viewers.

IT IS ORDERED by the Board of County Commissioners of Tulsa County, Oklahoma in regular session, that said Petition for said Draimage District and said improvements therein, and the said report of said viewers thereon, be and the same is hereby set for a hearing upon the 2nd. dayof Denember 1929, at the hour of 1:30 o'clock P M at the office of the Board of County, Commissioners of Tulsa County, Oklahoma, in the Court House, at Tulsa Oklahoma; and it is further ordered that notice thereof be given by publication for two successive weeks in the Skiatook News, a newspaper printed and of general circulation in said County, according to law, and that the last publication thereof be at least ten (10) days before the date fixed for said hearing.
