RESOLUTION

WHEREAS, a portion of Lots 1, 2, 3 and 4 in Oakley Addition to the City of Tulsa, Tulsa County, Oklahoma, is needed by the County of Tulsa in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners, Stella Ann Oakley and Carl H. Oakley, husband and wife, and from Federal National Mortgage Association, for a consideration of \$8,500.00, which amount is deemed to be fair and reasonable.

NOW WHEREFORE BE IT RESOLVED that the County purchase the East 30 feet of Lot 1; all of Lot 2 except the North 8 feet of the West 87 feet of said Lot 2; all of Lot 3 and the North 50 feet of Lot 4, all in Oakley Addition to the City of Tulsa, Tulsa County, State of Oklahoma, according to the recorded plat thereof, paying therefor the sum of \$8,500.00 upon claim executed by the said owners and by the Federal National Mortgage Association of Dallas as its interests may appear.
