WHEREAS, Tulsa County owns Ford Truck, 1933 Model, the Motor Number of which is 321543, and

WHEREAS, said Ford Truck being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department, to which said Ford Truck belongs, and was purchased and paid for from County Highway Funds; and

WHEREAS, the Highway Department is in need of an automobile and has found that a trade or exchange can be made with Abbott Motor Company for a 1940 Chevrolet Truck, Motor Number T2773808, in exchange for the Ford Truck and a further consideration of payment by Tulsa County to Abbott Motor Company the sum of Four Hundred and Eighty Dollars (\$480.00).

NOW, THEREFORE, BE IT RESOLVED, that the Chairman of the Board of County Commissioners be authorized to transfer title to the aforesaid Ford Truck and deliver same to Abbott Motor Company in exchange for the said Chevrolet Truck when accompanied by a proper transfer of title to Tulsa County, and that the County Highway Department be authorized to draw a claim to the Abbott Motor Company in the sum of Four Hundred and Eighty Dollars (\$480.00), payable from Account Number 8, designated as "Purchase of Tools, Trucks & Equipment" of the County Highway Department of the \_\_\_\_\_ Fund.
