to the North Line of said Section 35-19-12, a distance of 55 feet to a point; thence North along a line parallel to the said North and South Center Line of said Section 35-19-12, a distance of 183 feet to a point, said point being 274 feet South of the North Line of said Section 35-19-12, and 1,320 feet West of the NE corner of said NE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 35-19-12; thence East along a line parallel to the North Line of said Section 35-19-12, a distance of 256 feet to the place of beginning.

THEREFORE BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, that, for the proper construction of said road, this Board hereby determines that the acquisition of right-of-way on the above described tract of land is necessary, and since it appears that the agents of the County have been unable to secure same by amicable settlement, it is further resolved that the County Attorney be, and he is hereby authorized to institute condemnation proceedings for the acquisition of said right-of-way.

On vote, all members voting in the affirmative, the Chairman declared said motion carried and the resolution adopted.
