RESOLUTION

RESOLUTION, DIRECTING COUNTY TREASURER, AS CUSTODIAN OF FUNDS BELONGING TO PARK VIEW DRAINAGE DISTRICT No. 2, NOW IN HIS CUSTODY, IN THE APPROXIMATE SUM OF \$ 610.63, TO TRANSFER AND PAY SAME INTO THE MAINTENANCE FUND OF TULSA COUNTY DRAINAGE DISTRICT NO. 12.

WHEREAS, on December 7th, 1945, the District Court of Tulsa County, Oklahoma, entered a judgment and decree in civil cause No. 73806, John Hoffman, plaintiff, vs. Park View Drainage District No. 2, et al., defendants, abolishing and dissolving said Drainage District No. 2, and;

WHEREAS, at said time and on said date, here was in the custody of the County Treasurer of Tulsa County, Oklahoma, as custodian of the funds of said Park View Drainage District No. 2, the sum of Six Hundred Ten Dollars and Sixty-Three cents (610.63) in cash, which the Board of Commissioners for said Drainage Districts finds should be transferred to the maintenance fund of Tulsa County Drainage District No. 12, for the reasons alleged in the petition and stated in the decree;

WHEREFORE, IT IS HEREBY RESOLVED AND BY THIS BOARD DECREED that said County Treasurer be and is hereby ordered and directed to transfer said balance of funds now in his hands as such custodian, of approximately Six Hundred Ten Dollars and Sixty-Three cents (610.63) belonging to Park View Drainage District No. 2, to the maintenance fund of Tulsa County Drainage District No. 12, to be used as directed by this Board, and report his acts hereunder.

THEREUPON, on motion of Commissioner Greer, seconded by Commissioner Bailey, and a roll call and vote be taken thereon, the Chairman declared same unanimously carried and adopted.
