

The claims of J. J. Gilbert and I. F. Gilbert for damages to crop by water on June 6th, 1919 and the Claim of C. E. Stanley for damages and injuries received on the night of February 6th, 1919 in the sums of \$450.00 and \$2000.00 respectively were disallowed by the Board of County Commissioners. Said claims are now on file in the office of the County Clerk.

Thepetition of the Mackay Telegraph-Cable Company to construct, operate and maintain its telegraph lines, including the neecessary poles, wires and fixtures upon, along, over and across the Tulsa Sapulpa State Highway in Tulsa County, Oklahoma, was filed and approved by the Board of County Commissioners.

The official Bond of Aaron W. Bradshaw as Constable of Broken Arrow was filed with and approvedby the Board of County Commissioners.

The Affidavits of Erroneous Assessment of C. A. Sanderson and J. W. R. Attelbarger were ordered stricken bythe Board of County Commissioners.

The following bids were received at two o'clock P. M. for the construction of the Bridge across Caney River where the same crosses the south line of Section 10, Township 22 North, Range 14 East.

Joseph T. Lantry, Tulsa, Oklahoma, and
Concrete And Steel Construction Co., Joplin, Mo.

A motion was made by W. L. North and seconded by Ed Dalton that the contract for the construction of the bridge across Caney River where the same crosses the south line of Section 10, Township 22, Range 14 East, be awarded the Concrete and Steel Construction Company of Joplin, Missouri, sameto be constructed according to specification No. 7, | Said work to begin within fifteen (15) ~~xxxxxx~~ days from the letting of such contract and same to be completed within 120 days, or pay to Tulsa County TheSum of \$25.00 per day whhch is hereby acknowledged as liquidated damages due Tulsa County for failure to complete the work in the time limit specified therein, barring however, the action of the elements or cause beyond our control. Said motion was duly voted upon, and by the Chairman declared duly carried.

Upon motion of Commissioner W. L. North which motion was seconded by Commissioner Ed Dalton the following resolution was passed.

Whereas, begining August 1st, 1919, a rental of \$20.00 per month will be charged for each of the rooms now occupied by Justices S. C. Maxey and H. J. Gray in the Basement of the Tulsa County Court House, and Whereas, a rental of \$10.00 per month will be charged on the room to be occupied by justice H. T. Jones in the Basement of theTulsa County Court House. All said rentals being due and payable to Tulsa County thru the office of the County Clerk on the first of each month.

A motion was made by W. L. North and seconded by Ed Dalton that the County Engineer be instructed to repair and extend the bridge on Elm Creek between Sections 32 and 33, Township 21, Range 14, in Owasso Township by Force Account, amd furnish the Board of County Commissioners with an estimate of the cost of same. Said motion was duly voted upon and by the Chairman of the Board declared duly carried.

On motion of F. M. Wooden seconded by Ed Dalton W. L. North was chosen to act as a member of the Excise Board.

There being no further business coming before the Board at this regular meeting, said Board adjourned to meet again on Saturday July 26th, 1919.
