MANAGEMENT CONFERENCE
THURSDAY, OCTOBER 13, 1988

The Board of County Commissioners met at the hour of 9:00 a.m., with the following members present: John Selph, Chairman Pro-tem; Melvin C. Rice, Member. Members absent: Lewis Harris, Chairman. Others present: Clayton Edwards; Melody Bishop; Leroy Jones; John Cantrell; Joan Hastings; Dick Blakeley; Keith Hamilton; Mack Bettis; Jack Gordon; Wayne Green.

John Selph, Chairman Pro-tem, rpesiding, called the meeting to order at 9:00 a.m., and the following business was transacted:


Fred Swenson, General Manager of U.S. Recycling Industries, proposed a comprehensive recycling program to separate the plastic, aluminum cans, waste paper, computer paper, and glass containers from county government trash. Selph directed Edwards to review the program and bring a recommendation to the Budget Board.

Jones was present to discuss his memo of August 22, 1988, regarding the request from First Title & Mortgage Services, Inc., to provide a computer link with the Assessor's and treasurer's offices in order to obtain the necessary information to coordinate real estate closings. Selph stated there are a number of potential users. Selph directed Jones to work with all people involved and develop an agreement to be brought back to the board as soon as possible. All elected officials concerned are in agreement.

Gordon and Bettis were present to discuss Gordon's memo of October 13, 1988, regarding CAMA update. Gordon stated they are nearing completion of the second year of the five year revaluation cycle. As of January 1, 1988, all agricultural properties were revalued and placed on the assessment roll. Overall, they are on schedule to complete the fifth revaluation by January 1, 1992.

The meeting was adjourned at 10:00 a.m.
