The Board of County Commissioners met in an adjourned meeting on the 26th day of July at nine o'clock A. M. In the Commissioners' Room of the Tulsa County Court house. Present, F. M. Wooden, Chairman, W. L. North, V. Chairman and Ed Dalton, Member, and Lewis Cline County Clerk and Clerk of the Board.

Meeting was called to order by the Chairman, after which the business proceeded in regular order.

A motion was made by W. L. North and seconded by Ed Dalton that the Board of County Commissioners reissue the resolution of May 29th for Federal Aid, and a resolution of this day be approved. Said motion being as follows:-

"WHEREAS, the State Highway Commissioner has promised to aid Tulsa County in constructing that part of its system of improved Highways which includes the Skiatook, Bixby and Key Stone roads by recommending that the sum of \$600,000.00 Federal Aid Be granted to said County, and

WHEREAS, The estimated cost of building that part of said system included in he Federal Aid Project, embracing about 48 miles of the three roads mentioned above, is about \$1,275,000.00, and

WHEREAS, the Secretary of Agriculture of the United States before granting Federal Aid to any county or State requires that a showing be made that the County or state had or will have sufficient funds including the amount of Federal Aid recommended, to carry thru said improvement and finish the same, and

WHEREAS, the County of Tulsa has available from he sale of Highway Bonds the amount of \$1,620,000.00 or more.

NOW THEREFORE BE IT RESOLVED that there is hereby set aside for the purpose of constructing the highway improvement, included in Oklahoma Federal Aid, project No. 12, the sum of \$675,000.00 or as much in addition thereto as may be necessary. "

Whereupon said motion was voted upon and by the Chairman of the Board declared duly carried.

The Affidavic of Erroneous Assessment of J. W. R. Atterberger was ordered stricken From the Treasurers Tax Rolls by the Board of County Commissioners.

There being no further business coming before the Board for Comsideration at this adjourned meeting, on motion of W. L. North which motion was seconded by Ed Dalton, this Board adjourned to meet Thursday, July 31st, 1919, at 8 o'clock A. M.

A motion was made by W. L. North and seconded by Ed Dalton that before any Deputy in any of the county offices can be promoted, said promotion must be submitted to and sanctioned by the Board of County Commissioners. Said motion carried.

A motion was made by W. L. North and seconded by Ed Dalton that two (20 of the deputies in the County Attorney's Office be allowed a salary of \$200.00 per month and Two (2) deputies a salary of \$175.00 per month. Said motion being voted upon, and by the Chairman declared carried.
