NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State ofmoklahoma, hereby approve the sale of said property so made by the County Treasurer to W J FITZMAURICE for a consideration of \$40.00 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to him a deed comveying to him all the right, title and interest of the County of Tulsa, State of Oklahoma in and to said procerty, and the County Clerk of Tulsa County is hereby directed to attest with his signature and attach the seal of his office.
