Moved by Commissioner Caffey, seconded by Commissioner Bailey, go approve the following resolutions and the same are hereby adopted. Upon roll call, motion carried.

RESOLUTION:

WHEREAS, Lots 15, 16 and 17, and a portion of Lots 14 and 18, of Block 2, Carbondale Second Addition to the City of Tulsa, Oklahoma, are needed by the County in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners, Glen B. Doke, and Ervile L. Doke, his wife, for a consideration of \$5,000.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase Lots 15, 16 and 17, and a portion of Lots 14 and 18, Block 2, Carbondale Second Addition to the City of Tulsa, Tulsa County, Oklahoma, according to the recorded plat thereof, all being more particularly described as follows, to-wit:

Commencing at a point on the West line of said Lot 18, 27 feet South of the Northwest corner thereof; thence in a Southeasterly direction across said Lot 18, to a point on the East line thereof, 37 feet South of the NE corner thereof; thence South along the East line of Lots 18, 17, 16, 15 and 14, to a point 35 feet South of the NE corner of said Lot 14; thence in a Westerly direction to a point on the West line of said Lot 14, 10.5 feet North of the Southwest corner thereof; thence North along the West line of said Lots 14, 15, 16, 17 and 18, to a point 25 feet North of the Southwest corner of said Lot 18, and the place of beginning,

paying therefor the sum of \$5,000.00, upon claim executed by said owners.

RESOLUTION

WHEREAS, a portion of Lots 6 and 9 in Cameron Cline Acres, an addition to the City of Tulsa, Tulsa County, Oklahoma, is needed by the County of Tulsa in connection with acquisition of right-of-way for the 51st Street Project; and

WHEREAS, said property can be acquired by amicable settlement from the owners, Charles C. Cline and Lena E. Cline, his wife, for a consideration of \$12,750.00, which amount is deemed to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED that the County purchase a portion of Lots 6 and 9 in Cameron Cline Acres, an addition to the City of Tulsa, Tulsa County, Oklahoma, according to the Recorded Plat thereof, said lots and parcel of land being more particularly described as follows, to-wit:

A portion of Lots 6 and 9 in Cameron Cline Acres an addition to Tulsa, Tulsa County, Oklahoma, according to the duly recorded plat thereof, more particularly described as follows, to-wit:

Beginning at the NW corner of Lot 6, of said Cameron Cline Acres, thence east on the north line of said Lot 6 to the NE corner thereof, thence North a distance of 20.06 feet to the NW corner of Lot 9, of said Cameron Cline Acres, thence East on the North line of said Lot 9, to the NE corner thereof, thence South on the East line of said Lot 9, a distance of 87 feet to a point, thence west and parallel to the North line of said Lot 9, a distance of 903.31 feet to a point, said point being 25 feet East and 87 feet South of the NW corner of said Lot 9, thence in a Southwesterly direction across said Lot 9 and Lot 6 to a point on the West line of Lot 6, said point being 20.15 feet North of the NW corner of said Lot 6, thence North on the West line of said Lot 6, a distance of 179.85 feet to the point of beginning.

paying therefor the sum of \$12,750.00 upon claim executed by the said owners.
