R E S O L U T I O N

This being the day heretofore fixed for the consideration of the proceedings establishing a water improvement district pursuant to the petition of H. E. Krause and others, the Board of County Commissioners being dully advised and having heard all who have presented protests, objections, or petitions regarding the formation of said improvement district, hereby finds and determines that on the petition of the owners of the following lands, namely:

All that land situated in Township Nineteen (19) North, Range Twelve (12) East, Tulsa County, Oklahoma, beginning at the Southwest corner of Section Thirty-Three (33), thence North along the West line of said Sect on Thirty-Three (33) to the South line of Highway Sixty-Six, thence North and East along the South line of said Highway to the West line of the East half ($E\frac{1}{2}$) of Northwest Quarter ($NW\frac{1}{4}$) of Section Thirty-Three (33), thence North along said line to the North line of Section Thirty-Three (33), thence East along the said North Section line of Section Thirty-Three (33) to the South line of Highway Sixty-Six, thence North and East along the South line of said Highway to the West line of the Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-Eight (28), thence North along said line to the center of said Section Twenty-Eight (28), thence East along the half-section line of Section Twenty-Eight (28) to the Northeast corner of the West Half ($W\frac{1}{2}$) of Southeast Quarter ($SE\frac{1}{4}$) of Section Twenty-Eight (28), thence South to the Southeast corner of the West half ($W\frac{1}{2}$) of Northeast Quarter ($NE\frac{1}{4}$) of Section Thirty-Three (33), thence West along the half-section line of Section Thirty-Three (33) to the Northeast corner of the West Half ($W\frac{1}{2}$) of Southwest Quarter ($SW\frac{1}{4}$) of Section Thirty-Three (33), thence South along the East line of West Half ($W\frac{1}{2}$) of Southwest Quarter ($SW\frac{1}{4}$) of Section Thirty-Three (33) to the South line of said Section Thirty-Three (33), thence West along the South Section line of said Section Thirty-Three (33) to the place of beginning, less the rights-of-way of the Frisco Railroad, Oklahoma Union Railroad and Highway 66, and less East Half ($E\frac{1}{2}$) of Lot Two (2), and Lots Three (3), Four (4), Five (5), Six (6), Seven (7), and Fifteen (15), Block One (1), Bozarth Acres and Lot Nine (9), Block Twelve (12) Opportunity Heights and Freeland Addition described as West Half ($W\frac{1}{2}$) Southeast Quarter ($SE\frac{1}{4}$), Section Twenty-Eight (28), Township Nineteen (19) North, Range Twelve (12) East.

East Half ($E\frac{1}{2}$) of Lot Two (2) and Lots Three (3), Four (4), Five (5), Six (6), Seven (7), and Fifteen (15), Block One (1), Bozarth Acres and Lot Nine (9), Block Twelve (12) Opportunity Heights and Freeland Addition described as West Half ($W\frac{1}{2}$) Southeast Quarter ($SE\frac{1}{4}$), Section Twenty-Eight (28), Township Nineteen (19) North, Range Twelve (12) East.
