Motion was made by Geo.E.Gilmore, seconded by Ira Short, that the appeal from the County Superintendent to the County Commissioners in reference to transfer of children from School District No. 28, to School District No. 22, Tulsa County, Oklahoma, be sustained as per resolution herein set out. Motion carried.

That, Whereas, on or about the 10th. day of June, 1922, the County Superintendent of Tulsa County, after a hearing before, transferred the following school children to-wit: Watt Hughes, Nita Bland, Ralph Root, Anna Cline, Reon Denny and Paul Denny from School District No. 28, to School District No. 22, Tulsa County, Oklahoma.

That, Whereas, School District No. 28, through its duly and legally constituted officers appealed to the Board of County Commissioners, of said County, and praying that said appeal be acted upon in compliance with Senate Bill No. 33, Chapter 13, Page 13, Session Laws of Oklahoma, 1919;

And, Whereas, said appeal has come on for trial several times before the Board of County Commissioners, and each and every time the duly constituted officers of School District No. 28 being present and at no time any person or persons representing School District No. 22, or said children so transferred, and at this time said appeal has again come on for hearing and School District No. 28, through its officers and attorney being present and insisting upon a trial.

Now, Therefore, after due consideration of said appeal and all the facts and the evidence introduced, the Board of County Commissioners in regular session is of the opinion that said appeal should be sustained;

Be it therefore resolved, that said appeal of School District No. 28, be sustained and that the school children heretofore mentioned be not transferred from School District No. 28 to School District No. 22, Tulsa County, Oklahoma, but they be and remain in said School District No. 28, for school purposes.
