The Board of County Commissioners further finds and determines that said petition of H. E. Krause and others is signed by a majority of the holders of titles to lands proposed to be included in the district located outside of the limits of incorporated towns and that said petition is in all respects legal and sufficient and that it is hereby further found and determined that due and legal notice has been erved upon all parties interested in said improvement in the manner provided by law and in proper time for this hearing; that said water improvement district as manded herein and proposed improvements therein will be conducive to the public health and welfare of said proposed district as amended and that the probable cost of said improvements will not be excessive.

NOW, THEREFORE, be it and it hereby is resolved by the Board of County Commissioners of Tulsa County, Oklahoma, that an election shall be and is hereby ordered to be held in the territory included within the proposed district as herein amended on the 1st day of April, 1941, from six o'clock A.M., until seven o'clock P.M., and that at said election there shall be submitted to the qualified electors therein to be by them voted upon the following proposition:

"Shall a water improvement district be established and organized pursuant to the provisions of House Bill 181 adopted at the 1925 session of the legislature of the State of Oklahoma (Chapter 145, Session Laws of Oklahoma, 1925) including the following territory:

All of that land situated in Township Nineteen (19) North, Range Twelve (12) East, Tulsa County, Oklahoma, beginning at the Southwest corner of Section Thirty-Three (33), thence North along the West line of said Section Thirty-Three (33) to the South line of Highway Sixty-Six, thence north and east along the south line of said highway to the West line of the East Half (E2) of Northwest Quarter (NW4) of Section Thirty-Three (33), thence North along said line to the North line of Section Thirty-Three (33), thence East along the said North section line of Section Thirty-Three (33) to the South line of Highway Sixty-Six, thence North and East along the South line of said Highway to the West line of the Southeast Quarter (SE1) of Section Twenty-Eight (28), thence North along said line to the center of said Section Twenty-Eight (28), thence East along the half-section line of Section Twenty-Eight (28) to the Northeast corner of the West Half (W2) of Southeast Quarter (SE2) of Section Twenty-Eight (28), thence South to the Southeast corner of the West Half $(W_{\overline{z}})$ of Northeast Quarter $(NE_{\overline{z}})$ of Section Thirty-Three (33), thence West along the Half-section line of Section Thirty-Three (33) to the Northeast corner of the West Half (Wa) of Southwest Quarter (SWa) of Section Thirty-Three (33), thence South along the east line of West Half (W2) of Southwest Quarter (SW1) of Section Thirty-Three (33) to the South line of said Section-Thirty-Three (33), thence West along the South Section line of said Section Thirty-Three (33) to the place of beginning, less the rights-of-way of the Frisco Railroad, Oklahoma Union Railroad and Highway 66, and less East Half (Ez) of Lot Two (2) and Lots Three (3), Four (4), Five (5), Six (6), Seven (7), and Fifteen (15), Block One (1), Bozarth Acres and Lot Nine (9) Block Twelve (12) Opportunity Heights and Freeland Addition described as West Half (Wa) Southeast Quarter (SE4), Section Twenty-Eight (28), Township Nineteen (19), North, Range Twelve (12) East.

Said election shall be conducted in accordance with the general election laws, and the regular election officials shall conduct the election at the usual or designated polling places for each regular precinct or part thereof within the proposed district, and the returns of said election shall be filed with the Board of County Commissioners.

The County Clerk is hereby directed to cause notice of such election to be given in full compliance with the requirements of the law and in particular to give two weeks notice by publication in The West Tulsa News, a newspaper printed in the County, of general circulation in the territory proposed to be included within the district, which notice may be substantially the following in form:
