Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 11:00 o'clock A.M., with all members present: John H. Miller, Chairman; J.B.H. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that Lots 15, 16 and 17, Block 27, Midland Addition to the Town of Bixby, Oklahoma, be and the same is hereby leased to R. A. Alby and George Rooks for a term of One Year at the rate of \$15.00 per year, same to run from the 3rd day of February, 1937 to the 3rd day of February, 1938.
