

Thursday August '21, 1919.

The Board of County Commissioners of the County of Tulsa, State of Oklahoma, met in an adjourned session on the 21st day of August, 1919, at 8 o'clock A. M. in the usual place in the Tulsa County Court House. Present:- W. L. North, V. Chairman, Ed Dalton, Commissioner and Lewis Cline County Clerk and Clerk of the Board of County Commissioners.

A motion was made by W. L. North and seconded by Ed Dalton that the Security State Bank of Tulsa, Oklahoma, be designated as a County Depository Bank when proper bond is filed and approved. Whereupon said motion was voted upon and by the Chairman declared unanimously carried.

A motion was made by W. L. North and seconded by Ed Dalton that the Right of Way for an electrical line be granted the Sand Springs Home as per the following order.

ORDER.

Now on this 21st day of August, 1919, the application of the Sand Springs Home, a corporation, for the use of certain public highways within Tulsa County, Oklahoma for the purpose of erecting and maintaining poles, wires and other apparatus and appliances for the purpose of transmitting and selling to the inhabitants and to other cities and towns in said County, electricity for light, heat and power, coming on to be heard, the Board finds that said petitioner, Sand Springs Home, is a corporation duly organized and existing under and by virtue of the laws of the State of Oklahoma, and is authorized by its charter to furnish electricity and heat, light and power to various inhabitants and municipalities within Tulsa County State of Oklahoma; that said Sand Springs Home has made application to the town of Sperry and Skiatook in said County for franchise to furnish said municipalities with electricity, and that it will be necessary to lay and maintain on the following public highways in said County, poles wires and apparatus and other appliances as may be proper to transmit said electricity to said municipalities, to-wit:-

On section line running North and south between sections 26 and 25 and sections 23 and 24, Township 20 North, Range 12 East, and on section line running east and west between sections 13 and 24, Township 20 North, Range 12 East, and on section line running east and west between sections 36-21-12 and 6-20-13 and 1-20-12, and on section line running north and south between sections 36-21-12 and 31-21-13 and on section line running north and south between sections 25-21-12 and 30-21-13 and on section line running north and south between sections 24-21-12 and 19-21-13 and on section line running north and south between sections 13-21-12 and 18-21-13 and on section line running east and west between sections 24 and 13-20-12, and on public roads running east and west through section 13-20-12.

IT IS THEREFORE ORDERED, that the Sand Springs Home be and is hereby authorized to use the above described public highways within said county and along such other section lines as petitioner may elect to use in said county for said purposes.

IT IS FURTHER ORDERED, that the installation of said poles, wires, etc., shall be made under the direction of the County Engineer and in such places and manner consistent with necessity to least interfere with other public uses of said highways, and said highways shall not be unnecessarily obstructed and shall in a reasonable time be placed as near as practicable in as good condition and repair as before such construction, at the expense of said Sand Springs Home; that in the event the Board of County Commissioners decide at any time to widen the highways so used by the Sand Springs Home, that the sand Springs Home will move its pole lines to conform with the said highways at its own expense, and under the supervision of the County Engineer, and said Sand Springs Home will hold the County Harmless from any liability arising from any negligence, act or omission.
