Motion by Commissioner Sallee, seconded by Commissioner Morley, that the application for additional and supplemental appropriation for the remainder of the fiscal year ending June 30th, 1941, in the amount of \$45,998.88, be and the same is hereby approved and ordered published in the Tulsa Daily Legal News, and then submitted to the Excise Board for their consideration.
