RESOLUTION

Be IT RESOLVED, that the Board of County Commissioners of Tulsa County, Oklahoma, does hereby relinquish all right, title or interest the said County of Tulsa may have in the following described real estate situate in the County of Tulsa, State of Oklahoma, to-wit:

The North five feet of Lot 2, Block 5, and South five feet of Lot 4, Block 10, and the North five feet of Lot 5, Block 10, RIDGE VIEW ADDITON, to the County of Tulsa, Oklahoma, according to the recorded plat thereof,

which the said County of Tulsa may have acquired by virtue of a certain Quit Claim Deed dated the 7th day of June, 1950, from Edanvi Builders, Inc., to the County of Tulsa, Oklahoma, and recorded in the office of the County Clerk within and for Tulsa County, State of Oklahoma in Book 2104, page 550, which said deed was given for the installation, maintenance and operation of all public utilities and sanitary and storm sewers only, and which said tract of land and easement for said purpose has never been used and accepted for the installation, maintenance and operation of public utilities and sanitary and storm sewers, and is not needed or required by the County for such purposes.

BE IT FURTHER RESOLVED, that the Chairman be, and he is hereby authorized and directed to execute and acknowledge this relinquishment in order that it may be recorded in the Deed Records in the office of the County Clerk of said County.
