

\$1500; for the County Home Demonstration Agent \$1000; for Office Assistant County Agent Salary \$1920; for salary or expense of a Negro County Agent \$--- for salary of expenses of a Negro Woman Agent \$---; the expenses to be paid monthly and the total amount paid in any one month not to exceed the proportionate part of the year the agent has worked.

COLLEGE FUNDS
AND EQUIPMENT

In addition to the funds furnished by the County, the Extension Division of the Oklahoma Agricultural and Mechanical College, operating with the United States Department of Agriculture will pay One Hundred and Ten Dollars \$110.00 per month on the salary of the County Agricultural Agent and will pay One Hundred & Ten Dollars (\$110.00) per month on the salary of the Home Demonstration Agent, also will pay ---- Dollars per month on the salary of an Assistant Agent, also will pay \$--- Dollars, on the salary of a Negro County Agent, and ---- Dollars on the salary of a Negro Woman Agent. The Extension Division of A & M College also agrees to furnish all agents employed with the franking privilege for the free use of the mails in sending of agricultural publications in the County, to furnish the agents necessary stationery, instructions and printed bulletins for their use offarmers in the County, both from the College and from the United States Department of Agriculture.

SUPERVISION.

The Extension Division of the Oklahoma Agricultural and Mechanical College also agrees to supervise the work of these agents, carefully looking after the same to see that the work is done efficiently and in a manner to be of the largest possible benefit to the people of the County, and to pay the expenses of the agents when they are authorized to attend any meetings outside of the county on official business.

SPECIAL AID

The said A & M College likewise agrees to send to the county special representatives to assist these agents on special tasks, and to hold educational meetings for the benefit of the farmers and to assist in every possible way in making the work in the county effective.

PAYMENT OF
SALARY

The Agent's salary should be payable on or after the first of each month on certificate from the Extension Division of the A & M College that the work has been duly performed and the agent is entitled to same.

CHANGE OF
AGENTS

In case of any dissatisfaction with work of the agent, on the part of the A & M College or on the part of the County Commissioners each shall notify the other party of such dissatisfaction and if the dissatisfaction cannot be removed and all parties fully satisfied, said agent shall be promptly removed. If an agent is removed by agreement between the parties, another competent and satisfactory agent shall be selected to continue the work to the completion of the contract in the same manner as originally provided.
