WEDNESDAY, JUNE 2nd, 1937.

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the affidavit of erroneous assessment filed by W. L. Reynolds covering Lot 12, Block 1, Jean Heights Addition to the City of Tulsa, Oklahoma, for the years 1930 to 1935, inc., be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the affidavit of erroneous assessment filed by E. E. Clulow, Agent for G. A. Jenkins, covering lots 5 to 9, and 10, 11 and 15, Block 17, Berry Addition to the City of Tulsa, for the years 1932, 1933 and 1934, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the report filed by Andy Stokes, County Clerk, for the month of May, 1937, be and the same is hereby accepted and filed. Motion carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the affidavit of erroneous assessment filed by M. E. Shepard covering a tract of land 100x150 NE NE, 26-20-12, Tulsa County, Oklahoma, for the years 1932, 1933 and 1934, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the appointments of H. H. Mahler and M. J. Glass as deputies in the County Assessor's office for a period of sixty days each at a salary of \$200.00 for each thirty days, beginning April 26th, 1937 and ending June 26th, 1937, be and the same are hereby confirmed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the affidavit of erroneous assessment filed by Anna E. Moore, covering Lots 1 and 8, Albert Pike Addition to the City of Tulsa for the years 1929 to 1935, inc., be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
