Motion made by Commissioner Hardesty, seconded by Commissioner Couch, and unanimously carried, that the following Resolution, upon the recommendation of the County Attorney's office, be and the same is hereby adopted, to-wit:

RESOLUTION

WHEREAS, heretofore, on the 24th day of December, 1927, a certain right-of-way deed was executed to Tulsa County, Oklahoma, by C. W. Bailey and Grace A. Bailey, covering a strip of land along the Northside of the NE1 of the NE1, and along the East side of the NE1 and the SE1 of Section 11, Township 19, North, Range 13 East, Tulsa County, Oklahoma, filed of record on December 27, 1927, in the office of the County Clerk within and for Tulsa County, Oklahoma, and recorded in Book 668, at page 139; and

WHEREAS, the area so deeded and actually intended for right-of-way purposes was not fully defined; and

WHEREAS, under the original grant Tulsa County owned the North 24.75 feet of the said NE4 NE4 of Section 11, Township 19 North, Range 13 East, and required the North 50 feet of said NE4 NE4 for right-of-way purposes; and owned the East 24.75 feet of the said NE4 and SE4 of Section 11, Township 19 North, Range 13 East, and required the East 50 feet of said NE4 and SE4 for right-of-way purposes; and

WHEREAS, it was the intention of the grantors in said right-of-way deed to convey, and it was the intention of Tulsa County, Oklahoma, by and through its Board of County Commissioners, to receive the North 50 feet of said NE1 NE1, and the East 50 feet of said NE1 and SE1 of Section 11, Township 19 North, Range 13 East, inclusive in each instance of the said 24.75 feet so held by Tulsa County under the original grant:

WHEREAS, it is the desire of the grantors in said right-of-way deed and Tulsa County, Oklahoma, by and through its Board of County Commissioners to more clearly define the location and area of said right-of-way grant; and

WHEREAS, the County of Tulsa makes claim only to the North 50 feet of the said NE1 NE1, and to the East 50 feet of the said NE1 and SE1 of Section 11, Township 19 North, Range 13 East, being so used for highway right-of-way purposes.

NOW, THEREFORE, BE IT RESOLVED:

(1) That the real estate set forth and described in that certain righy-of-way deed dated December 24, 1927, and filed of record December 27, 1927, in the office of the County Clerk of Tulsa County, Oklahoma, in book 668 at page 139, be more clearly and specifically described as follows:

The North fifty (50) feet of the Northeast Quarter of the Northeast Quarter of Section 11, Township 19 North, Range 13 East; and the East fifty (50) feet of the Northeast Quarter and the Southeast Quarter of Section 11, Township 19 North, Range 13 East, in Tulsa County, Oklahoma.

(2) That the County of Tulsa, Oklahoma, by and through its Board of County Commissioners, does hereby disclaim all right, title and interest in and to any area of land described in said right-of-way in excess of that hereinabove described.
