O R D E R

NOW, on this the 25th. day of November, 1929, the matter of the Petition of the Cunningham & Tadder Gas Company for permission to lay a pipe line along, under and across certain highways in said County and State, came up before the Board of County Commissioners of said County for hearing and it appearing to the Board and each of the Commissioners thereof that it was just, that the said Petitioner be permitted to use as much of the highways as designated by plat filed, and according to said description, which is as follows, to-wit:

"Beginning at a point at the NE corner of Section 29, Township 18 N., Range 13 E., then following the fence line West to the NW corner of the same Section a distance of one mile, then South along the West fence line of Section 29 and 32 in same Township and Range, and continuing on Sections 5 and 8 and Section 17, to a point approximately one-third of a mile South of the NW corner of Section 17, then in a Southeasterly direction parallel with the paved highway to a point approximately one-half mile West of the SE corner of Section 17 in Township 18 N., Range 13 E., a distance of approximately six miles. Then beginning at the NE corner of Section 32, Township 19 N., Range 13 E., and following the fence line West along Sections 32 and 31 and Section 36, Township 19 N., Range 12 E., to the Arkansas River Bank, being a distance of 2-3/4 miles. Then, beginning at the NE corner of Section 5, Township 18 N., Range 13 E., and following then fence line along Sections 5 and 6 in Township 18 N., Range 13 E., and Section 1, Township 18 N., Range 12 E., to the Arkansas River bank, being a distance of 2-3/4 miles. Starting again at the NE corner of Section 5, Township 18 N., Range 13 E., and following the fence line West of Sections 5, 8 and 17, Township 18 N., Range 13 E., to the SE corner of Section 17. Beginning at the NW corner of Section 10, and running West along the North fence line of Sections 9, 8 and 7, in Township 18 N., Range 13 E., and along Section 12, Township 18 N., Range 12 E., to the Arkansas River Bank, being a total distance of approximately 3-1/8 miles. Beginning again at the NW corner of Section 10, and running South along the West fence line of said Section, to the SW corner of Section 10, being a distance of One mile, then West along the South fence line of Sections 9, 8 and 7 to a point approximately 1/2 mile West of the SE corner of said Section; then running in a Northwesterly direction along the Arkansas River Bank to a point approximately 1/2 mile South of the NW corner of Section 7, then running North along said Section 7 to the NW corner of said Section. Thence beginning at the SW corner of Section 10 and running for a distance of one mile along the West fence line of Section 15 to the SW corner of Section 15, then West along the South fence line of Sections 16 and 17 to a point approximately 1/2 mile West of the SE corner of Section 17, Township 18 N., Range 13 E., then beginning at a point approximately 1/4 mile South of the NW corner of Section 30, Township 19 N., Range 13 E., and running along the West fence line of Sections 30 and 31, Township 19 N., Range 13 E., and Section 6, Township 18 N., Range 13 E., to a point located approximately 150 yards North of the SW corner of Section 6, then
