He stated the pay schedule, of which only 20% has been paid, has worked to our benefit. The Board took this under advisement and asked Mr. Moore to keep them updated.

Moved by Selph, seconded by Harris, to approve and authorize execution by Commission, the claims (includes payroll for 7 employees totaling \$2,204.31) that are in order as required by Title 19 O.S. 1505 D 11 and 12 and provided that all claims involving wages and/or salaries be subject to state and federal withholding tax, retirement fund and social security deductions.
