diagonally across the corner of said Section to the paved road, being an approximate distance of 2-7/8 miles".

AND, it further appearing from the petition herein that said pipe line will be so constructed as not to interfere with any of the rights of the general public in the use of said highways, and will be constructed in accordance with all rules of the County Commission ers and the laws of the State of Oklahoma governing same;

IT IS HEREBY ORDERED AND ADJUDGED by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to the CUNNINGHAM-TADDER Gas Company, their successors and assigns to use as much of the highways as above designted.
