MONDAY, JANUARY 21st, 1935.

The Board of County Commissioners met in regular session on Monday, January 21st, 1935, at the hour of 10:00 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and H. E. Bridges, Members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted:

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the affidavit of erroneous assessment of the General American Tank Car Corp., covering Three Hundred Nine (309) tank cars for the year 1934, together with the accrued penalties on the valuation represented by these cars which is in the amount of and the County Clerk be instructed to issue a certificate of error. \$3,576.80/ Upon roll call, all members voting in the affirmative, motion was declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the official Bond of John P. Boyd be approved and filed. Motion carried.

Motion was made by Commissioner Bridges, seconded by Commissioner Miller, that J. H. Bolton be appointed Constable for District No. 10, Jenks/ All members voting in the affirmative, motion was declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that John M. Couch be appointed Constable for District No. 16, Collinsville, subject to the approval of his bond. All members voting in the affirmative, motion was declared carried.

Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that the affidavit of erroneous assessment of the Oklahoma Tractor & Equipment Company, be approved, and the County Clerk be instructed to issue a certificate of error in the amount of \$364.59. All members voting in the affirmative, motion was declared carried.

O R D E R

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to MRS. GRACE ATWOOD of a deed conveying to him for a consideration of Five and No/100 dollars (\$5.00) the following described lot:

Lot 15, Block 8, Settles Add. to Collinsville.

AND WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the compiled Statutes of Oklahoma of 1921, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax resale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Collinsville News, the official paper of the County of Tulsa, that said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other person having appeared to bid a higher price for the purchase of said lot, and the County of Tulsa has no need for said lot for any purpose required and provided by law whatsoever.

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treasurer to MRS. GRACE ATWOOD for a consideration of \$5.00 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to MRS. GRACE ATWOOD a deed conveying to her all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property, and the County Clerk of Tulsa County is hereby directed to attest with his signature and attach the seal of his office.
