WHEREAS, the Highway Department is in need of a Caterpillar Motor Grader, and has found that a trade or exchange can be made with Herd Equipment Company for a new Galion 101 Diesel Tandem Drive Motor Grader, Model G-28492, Serial M-6328, Motor UDF 15394, in exchange for the Caterpillar No. 11, Diesel Tandem Drive Motor Grader, and a further consideration of payment by Tulsa County to Herd Equipment Company the sum of Sixty-One Hundred Seventy-Nine Dollars and Eighty Cents (\$6179.80).
