WHEREAS, due notice has been given and published by the County Treasurer in the Skiatook News the official paper of the County of Tulsa, that said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other persons having appeared to bid a higher price therefore for the purchase of said lot, and the County of Tulsa has no need for said lot for any purpose required and provided by law whatsoever.
