

At a meeting of the Board of County Commissioners of Tulsa County, held in the Court House, in the City of Tulsa, Tulsa County, Oklahoma, on the 18th. day of April, 1932. at which all the members were present, the following Resolution was adopted:

RESOLVED, WHEREAS, The Fourth National Bank of Tulsa, as Principal, and the United States Fidelity and Guaranty Company, as Surety, have heretofore executed and delivered to Tulsa County, a certain Bond No. 18-11-27-31, in the amount of \$35,000.00, which Bond was dated April 23, 1931, and was given for the purpose of protecting the County against loss by reason of depositing County Funds in said Bank; and

WHEREAS, The Fourth National Bank of Tulsa has made other arrangements to secure said deposits and the purpose for which said Bond was written will terminate and expire April 23rd, 1932.

NOW, THEREFORE, BE IT RESOLVED, THAT said Bank be authorized to cancel said bond and that the United States Fidelity and Guaranty Company is hereby authorized, directed and empowered to cancel said bond and terminate its liability thereon from and after April 23rd, 1932.

In the matter of the laying of pipe line under and across certain highways, the following order was made:

O R D E R

Now, on this 18th. day of April, 1932, the matter of the petition of K C DORN of Tulsa, Oklahoma, for permission to lay a two inch gas line through culvert across certain highway in said County and State, came up before the Board of County Commissioners of said County for hearing and it appearing to the Commissioners and each of the Commissioners thereof, that it was just that the said petitioner be permitted to use as much of the highway as designated by map filed, and according to said description, which is as follows, to-wit:

In the East Half (E $\frac{1}{2}$) of the Northeast Quarter
NE $\frac{1}{4}$) of Section Fourteen (14), Township Twenty-
One (21), N) Range Twelve (12), East.

AND, it further appearing from the petition herein that said pipe line will be constructed so as not to interfere with any of the rights of the general public in the use of said highways, and will be constructed in accordance with all of the rules of the County Commissioners and the laws of the State of Oklahoma governing the same.

IT IS HEREBY ORDERED, by the Board of County Commissioners of said County that permission be granted, and the same is hereby granted to the said Petitioner, his successors and assigns, to use as much of the highway as above designated.
