Coming on for a hearing is Zoning Application C2-202, Lawrence H. Collins, Applicant, tract situated NEC of 45th West Avenue and 56th St. South. Chairman advised \$50. publication fee has been received and the hearing will proceed. Jay Stump, INCOG, was present and stated the Planning Commission voted to recommend approval of IL zoning. Chairman asked if anyone present to speak for or against the application. Mr. Jim Barker, Attorney for applicant gave surrounding area description and stated Mr. Collins plans a truck repair shop and the building he plans to construct will be an improvement to this area. They will plant foliage to screen the area or put up a wooden fence if required. He stated plans for this tract require it to be IL zoning. Mary Weaver, protestant, stated the residents in this area are against it because of the noise and fumes from trucks. She is afraid the oil from the trucks on the ground will kill her trees, the hours of operations and wants the fence line to be kept clean. Mr. Collins, applicant, stated there will be no oil on ground and will keep hours of operations as normal as possible. Selph stated that Ron Fields, Inspections, will track this and if residents have any complaints to notify his office. Moved by Dick, seconded by Selph, to approve IL zoning as recommended by Planning Commission and Planning Commission staff. Upon roll
