At a meeting of the Board of County Commissioners of Tulsa County, State of Oklahoma, held on the 16th. day of February, 1925, motion was made by Ed W.Hedgecock, which motion was seconded by W L North, that the County Engineer be directed to advertise for proposals for the paving with concrete, beginning at the town of Collinsville and extending West along the Collinsville-Skiatook County Highway, to a connection with the southern terminus of Section "C" Federal Aid Project No.111.

The motion being voted upon, was declared carried.

Motion was made by W L North, which motion was seconded by Ed W.Hedgecock, that the offer as made by the Braden interests and others, which tenders to the County a bonus of \$15,000, toward the cost of paving one and one half miles east on Eleventh Street, beginning at Harvard Avenue and Eleventh Street be approved, and that the County Engineer be directed to prepare necessary plans and specifications and advertise for proposals for such improvement.

The motion being voted upon, was declared carried.
