FORM OF PROPOSAL.

Board of County Commissioners,  
Tulsa, Oklahoma.

Gentlemen:-

We, the undersigned, hereby proposes to furnish all the material and equipment and do all the work of construction of the State Road Section described as follows:

"Beginning at Sta. 799 / 38.1 Tulsa-Skiatook Road, running West to Sta. 815 / 83.1; thence North to Sta. 826 / 73.1; being North line of "B" and Main Street of Skiatook, and necessary connections at "B" and Main Street"

which work is to be done in strict accordance with the plans and specifications approved by
