MANAGEMENT CONFERENCE MINUTES

WEDNESDAY, DECEMBER 24, 1986

The Board of County Commissioners for Tulsa County, Oklahoma met at the hour of 10:00 a.m., with the following members present: John Selph, Chairman; Melvin C. Rice, Member; and Lewis Harris, Member. Members absent: none. Others present: Clay Edwards, George Phillips, Richard Bales, Dr. Stephen Adelson, Jim Pugh and Melody Bishop.

John Selph, Chairman, stated this special meeting was called in order to discuss the Health Department's personnel action and to discuss the Park Board's fee structure recommendations for 1987.

Dr. Stephen Adelson, Chairman of the Board of Health, was present to discuss the Health Department's personnel action for the hiring of Dr. Ray D. Baker. Dr. Adelson stated 7 candidates were interviewed and the Board of Health agreed that Dr. Ray D. Baker's personnel action should be approved by the Board of County Commissioners in the amount of \$7,583.33 per month, effective January 1, 1987. The
