IT IS FURTHER ORDERED, that at any time it becomes necessary to repair the floor of said bridge, or to make other repairs on same, where said pipe line will interfere with the making of such repairs, that said corporation will remove said pipe line and will suspend same from underneath the floor thereof, so as not vto interfere with repairs or traffic thereon.

T. C. Ottinger, Anadarko, Oklahoma, Joseph T. Lantry, Tulsa, Oklahoma, and
Roach and McNulty, Tulsa, Oklahoma, and after a due consideration of said proposals
submitted, it was moved by W. L. North and seconded by Ed Dalton that the contract
for the construction of the drainage openings on mile 7 of Section "Y", and miles
for the construction of Section "Al" Tulsa County State Highways be wwarded, Roach and
McNulty, they being the low bidders.

A motion was made by W. L. North and seconded by Ed Dalton that the contract for the grading of the above specified highways be awarded Joseph T. Lantry, with Earth Excavation @ 42¢, Earth Borrow @ 42¢, Loose Rock Excavation @ \$1.00 and Solid Rock Excavation @ \$2.20 and Overhaul (haul beyond 500 Ft. Free haul) .05¢ per Cubic Yard;

And that the County Cterk and the Chairman of The Board of County Commissioners be authorized to enter into a contract with each of the above contractors, and that the contractor file a bond for the faithful performance of his duties, in the amounts of \$750.00 and \$5000 respectively.

A motion was made by Ed Dalton and seconded by W. L. North that all other checks be returned to their respective bidders, which was accordingly done.

The next business coming before the Board was the appeal of the petitioners of School District No. 25, from the decision of the County Superintendent on September 13th, 1919, by virture of such decision School District No 25 was attached to School District No. 26, and the Board of County Commissioners held that the County Superintendents ruling in the annexation of School District No. 25 to School Distric

There being no further businness coming before the Board for consideration at this meeting said board adjourned to meet, Thursday, October 9th, 1919.
