R E S O L U T I O N

WHEREAS, Tulsa County has an uncompleted informal contract (#227) with Mrs.John Cronin, for the grading of a certain section of County Highway, and

WHEREAS, Tulsa County desires at this time to do additional grading in the immediate vicinity of this project, and

WHEREAS, said Contractor has agreed to receive the same prices which prevail in the original contract.

NOW, THEREFORE, BE IT RESOLVED, That Contract No. 227 be and the same is hereby extended to include the grading of the following mile:

"Between Sections Nineteen (19) and Twenty (20)
Township Nineteen (19) North,Range Twelve (12)
East, same being Mile 4-b of Section "A-1",Tulsa
County Highway."

All voting in the affirmative, motion was declared carried and the resolution adopted as read.

The Affidavits of Erroneous Assessment of F L Smith and R G Ballard were ordered approved and Certificates of Error to issue to the County Treasurer.
