WHEREAS, In the Budget as approved by this Board for construction work for the fiscal year ending June 30th. 1923, there was set out among other things, that a portion of the State Highway between the Town of Owasso and Collinsville be paved with concrete.

AND, WHEREAS, said program being approved by this Board, and tentatively approved by the Excise Board of this County,

NOW, THEREFORE, BE IT RESOLVED, That this Board deems it to be to the best interest of Tulsa County, to call for proposals to be submitted to this Board on the 6th day of November, for the paving with concrete and the other items of construction incident thereto, that part of the Tulsa-Owasso-Collinsville Road, described as beginning at Station 665/60.3 which point is the present end of the concrete pavement on the west side of the east siding of the Santa Fe Railway, and entending through the Town of Owasso following the State Highway to Station 794 / 80, being the corners of Section 18-19-17 and 20, Township 21 North, Range 14 East, with the privile e on the part of this Board, that if an award be made on the date mentioned, that the contract may be extended, if funds are available for such purpose, provision being hereby expressly reserved by this Board that the right is held to reject any or all bids, or not to award a contract at such time in event the appropriations of this County be not made at such time.

BE IT FURTHER RESOLVED, That the County Engineer be instructed to advertise for proposals, which proposals will be opened and considered by this Board on the 6th. day of November 1922, between the hours of Two (2) and Three (3) o'clock P.M. of said date, for concrete pavement, and the other items of construction incident thereto, to be bid on according to the Tulsa County Standard Plans and Specifications as heretofore approved by Tulsa County and the Oklahoma Department of Highways.
