## ORDER.

This matter coming on to be heard before us the undersigned, County Commissioners of the County of Tulsa, Oklahoma, on this 16th. day of March, 1925, and it appearing that all necessary and legal steps and procedure for the incorporation of towns in the State of Oklahoma has been complied with for the incorporation of the proposed townsite of GARDEN CITY, and it appearing that after due notice of an election to be held as required by law in Garden City on February 20, 1925, that said election was held on said date as by law provided and that the poles were open at 9 o'clock in the morning and closed at 4 and that ballots had been prepared bearing the words for incorporation (Yes" and the words for incorporation "No" that G Y Smith, W C Thrasher and H C Schultz were elected as inspectors of the election as shown by their affidavits presented to us and that the result of said vote for the incorporation of Garden City was as follows: 113 votes were cast for the incorporation and 3 votes were cast in opposition to the incorporation, and such statement as the result of the election has been verified by the statement of the inspectors above named and the Commissioners being satisfied of the legality of this election and being fully advised in the premises, hereby declare and order that the said town of Garden City is an incorporated town and shall be known he reafter as an incorporated Town by the name of "Garden City" and same shall be judicially taken notice of in all courts and places in this State without especially pleading or alleging the same, and have and possess all of the powers that incorporated towns are endowed with by virtue of the laws of the State of Oklahoma.
