same, and to construct buildings thereon for free fair pruposes, the same to be owned and controlled by such counties, the Board of County Commissioners of Tulsa County, in the State of Oklahoma, in regular session assembled, with all members present, does hereby call and proclaim a special election to be held throughout the said Tulsa County, in the State of Oklahoma, and in each voting precinct in said County, on Tuesday, the 26th day of Webruary, 1952, for the purpose of submitting to the qualified voters of said County the following Proposition:

PROPOSITION

"Shall the County of Tulsa, State of Oklahoma, by its Board of County Commissioners, incur an indebtedness by issuing its negotiable coupon bonds in the sum of SIX HUNDRED TEN THOUSAND (\$610,000.00) DOLLARS, for the purpose of providing funds to purchase lands, improve the same and to construct buildings thereon for free fair purposes within Tulsa County, State of Oklahoma, to be owned and controlled by said County, and levy and collect an annual tax, in addition to all other taxes, upon all the taxable property in said county, sufficient to pay the interest on said bonds as it falls due and also to constitute a sinking fund for the payment of the principal thereof when due, said bonds to bear interest at not to exceed four (4%) per centum per annum, payable semi-annually and to become due serially within twenty (20) years from their date, said bonds-to be known as 'COUNTY OF TULSA FAIR BONDS OF 1952'."

FORM OF BALLOT

The ballots issued in the special election shall set out the Proposition and Question for submission to the qualified voters of said County, as above set forth, and shall also contain the following words:

(A voter desiring to vote for the Proposition shall stamp an X in the square before and preceding the words "For the Proposition"; a voter desiring to vote against the Proposition shall stamp an X in the square before and preceding the words "Against the Proposition.")

The Proposition for a purposed Public Health Center bond issue to be voted upon at the same election, may be printed on the same ballot form and election returns.

The polls shall be opened in the forenoon at 8:00 o'clock and shall be kept open continuously until the hour of 6:00 o'clock in the afternoon on said 26th day of February, 1952, provided, that in cities of the first-class in said County the polls shall be opened at 6:00 o'clock in the forenoon and shall be kept continuously open until the hour of 7:00 o'clock in the afternoon on said 26th day of February, 1952, all as provided by Sec. 251 of Title 26, O.S. 1951.

That for the purpose of said election hereby called and proclaimed, the number and location of the polling places shall be as heretofore officially designated by the Tulsa County Election Board of Tulsa County, Oklahoma, and the regular precinct boundaries for said Tulsa County shall be as heretofore designated by said County Election Board, and the said election shall be conducted by the duly qualified election officials of such county, and by the regular precinct officials heretofore officially designated by said County Election Board.

The duly qualified election officials of each voting precinct in said County shall make returns of the results of voting at their respective voting places, as provided by law, to the County Election Board of Tulsa County, Oklahoma, and said County Election Board thereafter, and at the time and in the manner and form as provided by law, shall proceed to canvass said returns and certify the result of said special election in form of law, to the Board of County Commissioners of Tulsa County, in the State of Oklahoma, and it is hereby specifically proclaimed that said special election hereby called and to be held on Tuesday, the 26th day of February, 1952, shall be conducted by the duly qualified election officials of said County and the returns thereof shall be canvassed by the Election Board of Tulsa County, Oklahoma.

AND, IT IS HEREBY ORDERED that this proclamation be published in five (5) consecutive issues of the Farm and Home, a weekly newspaper published and of general circulation in said County, and said publication shall be on the following dates: January 24th, January 31st, February 7th, February 14th, and February 21st, 1952.
