TO THE EXCISE BOARD OF TULSA COUNTY, OKLAHOMA:

Gentlemen:

In pursuance of the provisions of Section 12680, Oklahoma Statutes of 1931, as amended by H.B. 503, Acts of Sixteenth Legislature, application is hereby made for additional and supplemental appropriations with which to meet the legal and ordinary expenses of Tulsa County, Oklahoma, for the remainder of the fiscal year ending June 30th, 1937.

In support thereof, we do hereby certify:

First: That certain appropriations heretofore made are inadequate to properly maintain the County Highway Fund of Tulsa County, Oklahoma, for the current fiscal year, and that the public welfare and needs of said County are such as to require for the remainder of said year, for legal and ordinary expenses, the additional appropriations as listed and set forth by purposes and amounts in Exhibit "A" attached, and made a part hereof.

Second: That the financial statement hereto attached and marked Exhibit "B" shows as of the close of business June 20th, 1937, and preceding the filing hereof the true and correct condition of the County Highway Fund of said municipality and the surplus of \$24,051.61 thereon shown is available for additional appropriations.
