County Commissioners, incur an indebtedness by issuing its negotiable coupon bonds in the sum of THREE HUNDRED FIFTY THOUSAND (\$350,000.00) DOLLARS, which together with funds to be provided by the Federal Government shall be used for the purpose of constructing and equiping a hospital within Tulsa County, State of Oklahoma, the same to be of the type of hospital facility defined by Sections 329.5 and 329.6 of Title 63, Oklahoma Statutes 1951, as public health centers, to be owned, controlled and operated by said County of Tulsa, and levy and collect and annual tax, in addition to all other taxes, upon all the taxable property in said County, sufficient to pay the interest on said bonds as it falls due and also to constitute a sinking fund for the payment of the prinicipal thereof when due, said bonds to bear interest at not to exceed four (A%) per centum per annum, payable semi-annually and to become due serially within twenty (20) years from their date, said bonds to be known as 'COUNTY OF TULSA PUBLIC HEALTH CENTER BONDS OF 1952'."

## SECTION 2.

The Clerk of the County shall be, and he is hereby authorized to casue to be published in the Farm and Home, a weekly newspaper published and of general circulation in said County, Notice of said election said Notice to be signed by the Chairman of said Board, attested by the County Clerk, with the Seal of said County affixed thereto, and shall set out the date and purpose of the election, amount of bonds proposed to be issued, the length of time the bonds are to run, the rate of interest, and number and location of the polling places, the names of the Inspector, Judge and Clerk of each precinct who shall conduct said election, and the hours at which the polls shall be opened and closed.

## SECTION 3.

The ballots shall state the Proposition to be voted upon substantially as set out in Section 1 hereof, and may included thereon, but separately therefrom, the Proposition for the proposed County of Tulsa Fair Bond issue being voted upon at the same election, and said election shall be conducted in the manner prescribed by the general election laws of the State of Oklahoma for holding general elections, and by the duly qualified election officials.
