WEDNESDAY, JUNE 30th, 1937.

A special meeting of the Board of County Commissioners was called by the Chairman, John H. Miller, on Wednesday, June 30th, 1937, at the hour of 11:30 o'clock A.M., with all members present: John H. Miller, Chairman; J. B. Gray and Harry L. Hopkins, Members. Andy Stokes, County Clerk.

Chairman Miller presiding, the following business was transacted.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the hospitalization be fixed at \$3,000 per month for the months of July, August and September, 1937. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion by Commissioner Hopkins, seconded by Commissioner Miller, that for the month of July, 1937, the following amounts be given the following Hospitals: Morningside Hospital, \$1,800; Sisler Hospital, \$900.00; Poole Hospital \$100; and St. John's Hospital \$200.00 Upon roll call, the following vote was taken: Miller, Yes; Hopkins, Yes; Gray, No.

Motion by Commissioner Hopkins, seconded by Commissioner Gray, that the following amounts be allocated to the following for Drugs and Supplies for the month of July, 1937: Red Fork \$30.00; Sperry \$25.00; Skiatook \$10.00; Dr. Smith \$50.00; Sand Springs \$25.00; Collinsville \$50.00; Bixby \$50.00; Broken Arrow \$50.00; Jenks \$25.00; Dr. Motley \$75.00; Dr. Barham \$150.00; Dr. Roberts \$50.00; Dr. McGuire \$5.00; Dr. Roberts, for the jail \$100.00; Clinic \$100.00; Wm. Penn Drug Store \$400.00, to be divided as follows: Dr. Roberts \$100.00; Dr. McGuire \$25.00; Dr. Motley \$50.00 and Dr. Barham \$225.00. Dr. Childs \$60.00 and Dr. Hairston \$40.00. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

The following was directed to Morningside Hospital; Sisler Hospital, Poole Hospital and St. John's Hospital:

Gentlemen:

The County Commissioners in a meeting this morning allocated for the months of July, August and September \$3,000 for hospitalization, and for the month of July this money is to be divided as follows: \$1,800 to Morningside Hospital; \$900.00 to Sisler Hospital; \$200.00 to St. John's Hospital and \$100.00 to Poole Hospital.

It is impossible for the County Commissioners to determine at this time just how much we can set up in the budget for hospitalization this year and for that reason we have taken the action above mentioned. This money is to be spent for those that are on the County rolls and we will not be responsible for any bill over the amounts mentioned.
