AGREEMENT BY COUNTY TO MAINTAIN HIGHWAYS IMPROVED
UNDER PROVISIONS OF FEDERAL HIGHWAY ACT
AS AMENDED AND SUPPLEMENTED

The County of Tulsa, State of Oklahoma, hereinafter referred to as the County, and the Oklahoma State Highway Commission, hereinafter referred to as the Highway Department, hereby agrees as follows:

1. That the Highway Department will submit a project for the improvement of 0.9991 miles of the Secondary highway from A point on U.S. 64, Two Miles North of Bixby, East, to Old U. S. #64 Highway known as WILLOW SPRINGS ROAD and to be designated as Oklahoma Federal-Aid Secondary Project No. S-318(1), and will recommend its approval by the Federal Works Agency, Public Roads Administration for construction with funds apportioned to the State under the Federal Highway Act as amended and supplemented, subject, however, to the condition that the County shall provide for its proper maintenance after completion of its improvement.

2. That said County hereby requests the Highway Department to submit the aforementioned project with recommendation that it be approved by the Federal Works Agency, Public Roads Administration and agrees that if such project is approved and constructed by the Highway Department and the Federal Works Agency, Public Roads Administration, it thereafter, at its own expense, will maintain the project in a manner satisfactory to them, or their authorized representatives, and will make ample provision each year for such maintenance.
