

MONDAY, MARCH 25, 1946

Pursuant to recess heretofore taken, the Board of County Commissioners of Tulsa County reconvened at the hour of 10:00 o'clock A. M. with all members present: J. B. Gray, Chairman. Curtis Greer and Claude W. Bailey, Members. Andy Stokes, County Clerk.

J. B. Gray, Chairman presiding, the following business was transacted.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the report filed by Water Improvement District #3, Tulsa, Tulsa County, Oklahoma, for the period from December 19, 1945 to March 19, 1946, be and the same is hereby accepted and filed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the appointment of Walter Whisenhunt of Collinsville as a Deputy Sheriff at a salary of \$175.00 per month, effective April 1, 1946, replacing Grover Wagoner who resigned, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Bailey, that the appointment of Charles C. Weber as bailiff of Division No. 2, Court of Common Pleas, replacing T. H. Savage, at a salary of \$125.00 per month effective March 16, 1946, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that upon the recommendation of Joe. T. Parkinson County Treasurer, a duplicate County Deed be issued to Community Church of Collinsville, Oklahoma, covering Lot 5, Block 31, Original Town of Collinsville, for the reason that the original deed was lost or destroyed and had never been placed of record, and the Chairman be and hereby is authorized to sign same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the following affidavits of erroneous assessments filed and approved by Dan A. Rowe, County Assessor and William M. Taylor, Assistant County Attorney, be and the same are hereby approved, and the County Clerk is hereby instructed to issue Certificates of Error covering same. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
