

Motion by Commissioner Shepard, seconded by Commissioner Sallee, that the following Resolution be adopted. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

R E S O L U T I O N

WHEREAS, on the 17th day of February, 1941, the Board of County Commissioners of Tulsa County, Oklahoma, acting upon the report of the viewers appointed by this Board to report on the creation of a levee and drainage district, designated at Tulsa-Sand Springs Levee and Drainage District, which said report, having been filed for the consideration of this Board bearing date of January 14, 1941, and, which said report was accepted and approved by this Board on the 29th day of January, 1941, did, on the date first above set out; namely, 17th day of February, 1941, by resolution, order that a Notice be published, in accordance with the Statutes governing, fixing a date for a public hearing; said date being set for March 17, 1941; which said notice was duly published in the "Legal News", a publication of general circulation, on the 20th day of February, 1941, and, on the 27th day of February, 1941, and on the 6th day of March, 1941, giving notice to all concerned of the date of and the purpose of said hearing; and

WHEREAS, This Board convened, at the hour of 10:00 o'clock A .M., on the 17th day of March, 1941, for the purpose of hearing any and all protests coming before the same, in protest to the creation of the aforesaid proposed Tulsa-Sand Springs Levee and Drainage District, or, in protest to being included within the said proposed Levee and Drainage District, and

WHEREAS, there was filed, as a protest, either in writing or verbally, protests from the following persons owning and alleging that they own property that would be liable to assessment for benefits, being located within the proposed confines of said proposed levee and drainage district, namely, to-wit:

WHEREAS, there being no further protests it was the order of this Board that said hearing be closed, and the Board adjourn to this date, March 24, 1941.

WHEREAS, subsequent review of all protests so filed, both in writing and orally, clearly indicate the protestants to be representative of only a minor portion of the area; of the taxable value ; and of the owners of property confined in the area proposed to be included in the Tulsa-Sand Springs Levee and Drainage District; therefore, it is the order of this Board that the said protests be overruled; that the Levee and Drainage District be created, embracing the area as set out in the report of the viewers as filed with this Board bearing date of January 14, 1941; accepted and approved by this Board on January 29, 1941; said Levee and Drainage District to be named and known as Tulsa-Sand Springs District, Tulsa County Drainage District No. 11.

BE IT FURTHER RESOLVED, that the principal J. N. Lane and the Sureties Dan W. Patton and John F. Conway be now released from the Surety Bond bearing date of October 7, 1940, in the amount of Two Hundred and Fifty Dollars (\$250.00) which said Bond accompanied and was filed with the Petition of J. N. Lane, et al., petitioning creation of the herein referred to Levee and Drainage District; and

BE IT FURTHER RESOLVED having determined that the said Levee and Drainage District is of private and public necessity and benefit, is conducive to public health, sanitation, etc., and, having been so ordered, it was moved by Commissioner Shepard that request to the Judge of the District Court for appointment of three viewers, as provided by Section 13010 of the 1931 Oklahoma Statutes, be for the time being, deferred; that this resolution be adopted. Commissioner Sallee seconded the motion and upon roll call, the following vote was:
