Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Parkinson, County Treasurer, the resignation of Lucy Hatfield, Deputy County Treasurer, be and the same is hereby accepted, effective as of March 31, 1946. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

There being no objections or corrections, motion made by Commissioner Gray, seconded by Commissioner Bailey, that the minutes stand approved as read.
